### POTENTIAL HEALTH EFFECTS

**EYE:**

May cause moderate eye irritation, which may be slow to heal. Vapors may irritate eyes.  
May cause moderate corneal injury.

**SKIN:**

Low order of toxicity. Prolong or repeated exposure may cause skin irritation. A single prolonged exposure may result in the material being absorbed in harmful amounts. Excessive exposure may cause hemolysis. Repeated minor exposure may result in absorption of harmful amounts.

**INGESTION:**

Minimal toxicity. Single dose oral toxicity is considered to be moderate.  
Small amounts swallowed incidental are not likely to cause injury.

Swallowing larger amounts may cause injury.

**INHALATION:**

A single prolonged excessive inhalation exposure may cause adverse effect. Excessive exposure may cause irritation in the upper respiratory tract.

**TERATOLOGY (BIRTH DEFECTS):**

Birth defects are unlikely. Exposures having no effect in the mother should have no effect on the fetus. Did not cause birth defects in animals.

**FIRST AID**

**EYE CONTACT**

Irrigate with flowing water immediately and continuously for 15 minutes. If irritation persists, get medical attention.

**SKIN CONTACT:**

In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated cloths and shoes. Call physician if irritation continues.

**INGESTION:**

If swallowed, induce vomiting immediately as directed by medical personnel. Never give anything by mouth to an unconscious person. Consult medical personnel.

**INHALATION:**

Remove the affected victim from exposure. Remove to fresh air if effect occurs. Consult a physician.

**Eliminate all sources of ignition in vicinity of spill or release vapor to avoid fire or explosion. For large spill, warn public of downwind explosion hazard. Check area with explosion meter before reentering area. Ground and bond all containers and handling equipment. Prevent liquid from entering sewers. Contain spilled liquid with sand or earth. Do not use combustible materials such as sawdust. Recover by pumping (use an explosion proof or hand pump) or with an expert absorbent.**

## SECTION 7: HANDLING AND STORAGE

---

### **HANDLING:**

**Containers, even those that have been emptied, can contain vapors. Do not cut, drill, grind, weld, or perform similar operations on or near empty containers. No smoking, open flames or sources of ignition in handling and storage area. Never use air pressure for transferring product. Electrically ground all equipment.**

### **STORAGE:**

**Keep containers tightly close when not in use.**
